It is our aim for children eligible for Pupil Premium funding at Bledlow Ridge School to reach the at least the same level of attainment as their peers. We realise this may mean these children need to make accelerated progress and will use the pupil premium finding to support pupils in overcoming a range of barriers that may be identified in school that may hinder this accelerated progress.

Challenges

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

- Giving additional 1:1 support to a child with additional needs as an EHCP had not been awarded, yet the children needed significant behavioural and academic support. This improved attainment in school significantly and the pupil reached the Expected standard in Reading and Maths in his end of year SATs.
 Behaviour and attitude to school was also greatly improved and engagement in lessons was significantly increased.
- 1:1 catch up support was given to all other pupils eligible for PP. This led to one children reaching the expected standard in Reading and Writing when they were working towards at the beginning of the year in all subject areas on entry to the school mid way through the year. Maths support will need to continue. A second pupil reached the expected standard in Maths having been WTS in Y2 and reached Greater Depth in Reading having been EXS in Y2. Writing will continue to be a focus. The third pupil narrowed the gap to the expected level in Maths and Reading and significantly reduced the gap between herself and her peers in Maths. Writing still needs further intervention.
- Funding was given to allow one pupil to access the Year 6 residential. This was
 their first time away from home and the confidence boost, and social wellbeing
 from attending this trip had a significant impact on him.
- Funding was given to allow one pupil to attend an afterschool sports club for two terms in 21/22.
- Additional 1:1 or small group tutoring was given to around 30 children across the school through the Catch Up premium funding. The significant majority of this children showed accelerated progress from the previous year and Autumn

assessments and narrowed the gaps to their peers during the year. Some of these children will still benefit from further support this coming year.
